2009 Rules and Regulations

Friends of Lopez Lake and San Luis Obispo County Parks are very excited to have you participate in this great event. Friends of Lopez Lake are a group of dedicated volunteers who love the Park, the Lake, the Wildlife and the environment at Lopez Lake Recreation Area. FOLL volunteers come from all over California to support park activities that due to budget constraints and lack of staffing could not exist. All vendor booth fees go to FOLL to support the parks activities and their long-term goal of a new Natural History Museum and Nature Center.

In an effort to make sure the event runs smoothly and all parties involved feel prepared, here is a list of Rules and Regulations for the Turkey Festival.

Directions: Driving north or south on Highway 101 take the Grand Avenue Exit in Arroyo Grande. Turn east towards the mountains and drive through old town Arroyo Grande to Huasna Road. Turn right onto Huasna Road, which turns into Lopez Drive. Stay on Lopez Drive for approximately 10 miles. At this point the road ends at the entrance to Lopez Lake. (Signs are posted along the way.) **The festival will be held at the Campaneros Area across from the entrance to the marina.**

Set up: Set up is between 8 am and 10 am. Vendors are allowed to use their vehicles to drop off equipment but must be removed from the event area by 9:30 a.m. Vehicles cannot block or hinder other vendors from setting up their booths. All vehicles will need to park in the parking area provided adjacent to the event area which will be in the marina parking lot.

Clean up: Clean up is between 3:30 pm and 4:30 pm. We ask that all vendors wait till 3:30 pm to break down their booth.

Electricity: There is limited use of electricity. If you need electricity please let us know one week prior to the event. You must provide your own extension cords.

Space Location: All vendors will be assigned a numbered space. Please check with event staff upon your arrival.

Food Vendors: All food vendors must comply with County Health Department Regulations. Please contact **the SLO County Health Department at 805-781-5514 for questions regarding booth requirements.** Proof of County Health Permits is required. Food vendors are also required to submit proof of insurance with San Luis Obispo County Parks listed as "additional covered." **Vendors without the above mentioned requirements would not be allowed to operate.**

Payment: Vendor Booth Fees are due with application by October 31st. No payments will be accepted during the event.

Cancellations: There will be no refunds in the event of bad weather (i.e. rain, wind etc.) There will be no refunds due to cancellations.
